



# Revell thinks inside the box at trial

Facing a high profile capital murder trial and an apprehensive judge, Tim Revell of The Columbus Dispatch came up with a unique solution to create courtroom images in the case of Columbus highway shooter Charles McCoy.

"The key to using the camera was a demonstration in the court room," said Revell. "Schneider was on the bench and asked for a demonstration. I said I had shot about 20 photos while he was talking to me. He did not hear the camera clicking

and he said it was good for the trial."

"We had court TV at the trial and they also set up a TV remote. I used a Canon 20D and a 50mm lens set on 1/80 at f5.6."

"It was wrapped in several small cloths and the trigger device was a pocket wizard. Sometimes the best photo of the day came from that camera because I got good reaction from McCoy and his defense team.'

The case ended in a mistrial after jurors failed to reach a verdict after 29 hours deliberations over Defense Attorney S. Michael Miller, left, and defendant Charles five days. McCoy later reached a plea agreement with prosecutors and was sentenced to 27 years.

newsroom cuts. Turning the page on a calendar probably won't make it go away either.

Cut was the word most used in headlines referring to print media. Usually this referenced jobs, space or advertising or sometimes all three.

All part of a grand plan to raise profit margins and increase revenue by making our products worse. Perhaps you need an MBA to understand the equation.

What puzzles the MBAless me is that the powers that be don't seem to understand why readers and advertisers are leaving in droves.

If General Motors launched a new

vehicle that was designed to offer the customer less value and quality than the product it was replacing you wouldn't need that MBA to project sales figures.

I can see Chevrolet telling their customers, "We know the recent trends have you looking at Toyota and that our cars no longer come with tires, we throw in the hubcaps free."

Customers are not stupid. Whether they plunk down \$28,000 for a new SUV or 50 cents for the local paper they recognize when they are being screwed.

Just ask the readers of The Plain Dealer who recently lost their Sunday Magazine. Ask the readers of the Akron Beacon Journal who saw the single copy price double while local sports and community news disappear

While companies point customers to their web sites, they don't give newsrooms the resources or training to provide the content for the paperless product.

In most cases the free content is

It will be known as the year of the harder to navigate than an orange-barreled interstate in rush hour.

Do I have a horse in this race? Working at one of the 32 papers owned by Knight Ridder absolutely. More than likely so do you. It's not a Knight Ridder issue. It's not a union vs. non-union issue. It's not a big paper, small paper issue. It's an industry-wide issue.

The corporate newsroom has problems beyond profit margins and stock prices. Creativity has been sucked out of the printed and electronic products as properties produce the "Stepford Pages", following the corporate mantra of one style fits all.

The days of stability at the helm are long gone as senior managers grab the next rung on the corporate ladder in a new city before they can pay off a

Before the ink is dry on their plan to reinvent the wheel, the replacement comes in with another recycled plan to save the paper. Take your pick. It's usually either the plan where we open bureaus in the burbs or the one where we close bureaus in the burbs.

Meanwhile those of us who call this our home are left with the readers holding the bag. The people who really care about the community are the big losers in this game of smoke and mirrors being played out for Wall

When will it all end? Perhaps when those in control start listening to their readers and employees instead of their high priced consultants.

Don't set your alarm clocks thinking these executives are going to wake up anytime soon. Most are in a deep sleep wondering when will be the best time to exercise their stock options.

I may not have a job at the end of the year. but I'm not drinking their Kool-Aid. I want the car with tires.

# Larger than life, it's supersized King James

Six columns is always a good measuring stick when talking about picture usage.

Ten stories beat six columns any way vou measure it. That's ten stories, like the kind that measure 110 feet high. In this case, it measures 212 feet wide or about 15,264 picas if you're on a pica pole.

The photo is a LeBron James breakaway dunk captured by Mark Duncan of the Associated Press during Jame's rookie sea-

The image graces a Nike billboard near the Terminal Tower directly across the street from Quicken Loans Arena. James is under a \$90 million endorsement contract with Nike.

A word of advice for photographers covering the Cleveland superstar. Be happy with five or six columns. Apologies to Mr. Duncan on the limited display in this publication.



## STILL CLIP RULES

Photos must be entered in the month published. A photo can be entered only after its initial publication. Publication is defined as printed or electronically reproduced by your publication's official Web site.

All Web published entries must be in the form of a hard copy no larger than 8 by 10 inches, with a screen shoot of the picture's online publication on the back

Submissions of wire photos will be handled similarly. If a clip of your AP submission is not available a print no larger than 8 by 10 inches may be entered. Attached must be a proof from your AP server of the photo or the routing code and date of transmission.

Remove your name and affiliation from the front of the clip. Affix

a completed official entry label on the back. Include a separate sheet of paper with your name, address and total number of clips entered.

Layouts are judged as a single entry but single pictures from a layout can be entered also. You must submit another clip of the single image from the layout in this case.

Sort clips by category: **Spot news:** A picture of an unscheduled event for which no advanced planning was possible. Examples: fires, accidents and natu-

**General news:** A picture of a scheduled political, social or cultural event for which advance planning was possible. An assigned and/or scheduled news event. Example: Demonstrations, funerals, trials and

Portrait: A picture of a person that reveals the essence of the sub-

**Sports:** An unposed sports-related picture, either feature or action. Sports-related portraits should be entered in the portrait category.

Feature single: A general human-interest photo.

Multiple pictures: A photo story, sequence or series of any subject

**Illustration:** A created picture, not a found situation or portrait. Intended to clarify or dramatize a preconceived idea. This would include illustrations depicting food, fashion, industrial or editorial topics. This category will be judged quarterly but clips must be entered in the most bright bad. the month published.

Each entrant is limited to a total of nine clips per month. The clip contest is open to all ONPA members in good standing who live or work in Ohio during the month entered. The ONPA clip contest is not affiliated with the NPPA Region 4 clip contest. Clips must be in the hand of the clip chairman by the 7th of the month following publication. Clips should be sent to






