


Nighswander settles Humes case

ATHENS, OH - According to a consent decree filed in Fairfield County Common Pleas Court, former Ohio University School of Visual Communication professor Larry Nighswander has agreed to pay OU student Rebecca Humes a new sum of \$10,000 to resolve her latest legal claim

The new consent decree says that Nighswander forbidden to make any public comment about the consent degree, Humes, or members of her family.

If Nighswander violates the terms of this latest settlement, he risks having to pay Humes an additional \$500,000, the consent decree says.

The Athens News reports this recent settlement stems from the discovery of photos of Humes found on Nighswander's computer equipment long after a \$3 million federal sexual harassment suit Nighswander by Humes against Nighswander



Humes sued Nighswander again in June 2006 in Fairfield County claiming a breach of that settlement agreement, along with fraudulent misrepresentation, after she and her lawyers learned from OU officials that the photos of Humes still existed on Nighswander's computer equipment, which had been discovered when police were searching Nighswander's computers while investigating an unrelated case.

In the original settlement, Nighswander agreed that any images he had of Humes would be "permanently and irretrievable deleted and/or destroyed." Nighswander testified in federal deposition in the case that he no longer had any images of Humes in his possession, the Athens News reported.

The initial federal sexual harassment lawsuit

stemmed from an incident in which Nighswander photographed the semi-nude Humes while she was an undergraduate student at OU. Humes claimed that during the photo session Nighswander touched her without her permission, and made inappropriate noises and comments. Nighswander denied any wrongdoing or sexual harassment but admitted to the photo session. After Humes sued Nighswander, at least two other female OU students came forward with similar allegations against Nighswander, the Athens News' Jim Phillips reports.

In July 2005, Fairfield County sheriff's deputies searched Nighswander's photography business near Pickerington, OH, while investigating a fraudulent e-mail that had been sent to an OU search committee. The e-mail was believed to have been sent from a computer at Nighswander's business, but no charges were filed following the investigation. However, in the course of examining the digital data on Nighswander's computers, sheriffs discovered the photos of Humes, which Nighswander claimed he had already destroyed, and they informed OU officials of the images. OU informed Humes and her lawyers, and in October 2006 the new suit was filed.

The settlement in this most recent case also says the Fairfield County sheriff's department will destroy any items that contain images of Humes. The other computer equipment cannot be returned to him, the consent decree says, until after Nighswander pays for a forensic computer expert, one approved by Humes, to certify that the equipment and discs do not contain any images of her, or contain anything from which the images of her could be restored.

The consent decree says that Fairfield County judge Chris Martin will keep jurisdiction over the case to make sure Nighswander complies, and so that he can start contempt proceedings if Nighswander doesn't comply. The decree says that if Nighswander violates the agreement he will have to pay Humes \$500,000 in damages plus any legal costs that Humes incurs obtaining court orders to halt any violation of the decree.

Don Bartletti to present lecture at KSU

Don Bartletti, who has spent the majority of his career as a photoiournalist with the Los Angeles Times and won the 2003 Pulitzer Prize for feature photography, will present the Gerald H. Read Lecture "The Roads Most Traveled — Photographs and Lecture of Migration" at 7 p.m., Nov. 1, in the Kent State Student Center, Kiva. The event is free and open to the public.

During his career, Bartletti has covered news stories and in-depth investigative projects throughout California and elsewhere in the United States, Africa, Central America, Europe, Mexico, the Middle East and South America. Hundreds of his photographs about migration for economic survival have appeared in the Los Angeles Times and other newspapers. His prints have been shown in solo and group exhibits nationwide and throughout Mexico. Many are held in museum collections, published in books and scholarly studies.
"Enrique's Journey," Bartletti's six-part photo

essay in the Los Angeles Times, touched his photojournalistic soul like few other projects. His images

of Central American children and young men struggling to reunite with their mothers in the United States anchors the singular subject he has chronicled throughout the past 26 years: The causes and effects of migration from Latin America to the United States.

Bartletti has been accorded more than 40 awards, most notably the 2003 Pulitzer Prize. Others include the Robert F. Kennedy Award, the George Polk Award, the Scripps-Howard Foundation Award, and honors from the National Press Photographers Association, the Pictures of the Year International, World Press Photo, National Association of Hispanic Journalists and the Inter American Press Association.

Split verdict in Toledo trespassing trial

TOLEDO, OH - A Toledo jury found photojournalist Jeffrey Sauger guilty of criminal trespass and photojournalist Jim West not guilty of failure to disperse at the conclusion of a three day trial in September.

The two photographers were on trial following their arrests in Toledo in December 2005 where they were covering a Nazi rally in the city. Police arrested and charged Sauger with criminal trespass and West with failure to disperse. The two contended at the time of their arrest they were standing in a designated "media" area on

A third photographer arrested that day, Jeffery Willis of the Toledo Journal, had disorderly conduct charges against him dismissed last year.

Sauger, writing about the verdict on a message board on SportsShooter.com, said that sentencing is set for next week before the trial judge, Lynn H. Schaefer. He says he's been told that he may be facing only paying court costs for the trial, but that's still uncertain at this

Police said Sauger lacked a temporary media credential for the event that had been issued to some news photographers earlier in the day. At the time of the arrest Sauger was standing in a media area, wearing his regular press credentials, and carrying and using professional

photography equipment

After Sauger and West were headed for trial there was an offer to drop the charges if the two photographers would sign a waiver releasing the City of Toledo from any responsibility. Sauger says that offer was quickly withdrawn when there was a change of prosecutors on the case.

"I'm sort of shell shocked that I was found guilty," Sauger wrote on the Internet message board. "In the scheme of things, this isn't like being tortured, beaten, injured, or killed; I'm thankful for that. I'm pissed off though. Civil rights in this country are going down the toilet and nobody seems to care."

Sauger says he's probably lost more than \$6,000 in freelance jobs and wages based on the amount of time he's had to spend fighting the charges and the number of trips he's had to make from his base in Royal Oak, MI, to photography before moving Toledo. Sauger says he thanks Gary Kemper, Tannen Maury, and his agency - European Pressphoto Agency for supporting him during the two years that have passed

"This is the type of crap our legal system puts people through and people have asked about my experience. It's no wonder people just sign waivers," Sauger wrote.

News merger in Youngstown

In the world of job losses the shoe seems to be on the other foot this time as two Youngstown area television stations enter an agreement which in all likelihood will result in a loss of jobs at both stations.

Parkin Broadcasting, new owners of ABC affiliate WYTV, has entered a shared services agreement with New Vision Television, owner of local CBS affiliate WKBN.

Employees at WYTV, can retain their jobs if they agree to give up their seniority and agree to be placed on a 90-day probationary peri-

Employees at WKBN were given the same option when New Vision bought that station earlier this year.

New Vision also has an option to buy WYTV after one year with a negotiated escalator clause to keep the option available for five

The FCC has approved the sale of WYTV to Parkin Broadcasting from Chelsey Broadcasting as well as the shared services agreement.

STILL CLIP RULES

Photos must be entered in the month published. A photo can be entered only after its initial publication. Publication is defined as printed or electronically reproduced by your publication's official Web site.

All Web published entries must be in the form of a hard copy no larger than 8 by 10 inches, with a screen shoot of the picture's online publication on the back. Submissions of wire photos will be handled similarly.

If a clip of a wire service submission is not available, a print no larger than 8 by 10 inches may be entered. Attached must be a proof from your AP server or other Web site of the photo or the routing code and date of transmis-

Remove your name and affiliation from the front of the clip. Affix a completed official entry label on the back. Include a separate sheet of paper with your name, address and total number of clips entered.

Layouts are judged as a single entry but single pictures from a layout can be entered also. You must submit another clip of the single image from the layout in this case.

Sort clips by category:

Spot news: A single picture of an unscheduled event for which no advanced planning was possible. Examples: fires, accidents and natural disasters.

General news: A single picture of a scheduled political, social or cultural event for which advance planning was possible. An assigned and/or scheduled news event. Example: Demonstrations, funerals, trials and promotional

Portrait: A single picture of a person that reveals the essence of the subject's

Sports: An unposed sports-related single picture, either feature or action. Sports-related portraits should be entered in the portrait category. **Feature single:** A general human-interest photo.

Multiple pictures: A photo story, sequence or series of any subject matter. **Illustration:** A single created picture, not a found situation or portrait. Intended to clarify or dramatize a preconceived idea. This would include illustrations depicting food, fashion, industrial or editorial topics. This category will be judged quarterly but clips must be entered in the month published.

Each entrant is limited to a total of nine clips per month. The clip contest is open to all ONPA members in good standing who live or work in Ohio during the month entered. The ONPA clip contest is not affiliated with the NPPA Region 4 clip contest. Clips must be in the hand of the clip chairman by the 7th of the month following publication. Clips should be sent to

SUBMITTING WINNING CLIPS

All winners in the monthly clip contest must submit a copy of the winning entry for the ONPA newsletter and/or web site. Winners will be notified via email, so remember to include your e-mail address on the back of each clip.

If you do not respond to the first notification in seven days a second notice will be sent. Failure to respond to the second notice in ten days will result in a loss of points for that clip win. If in subsequent months the same photographer fails to reply he or she will be disqualified from entering the contest for the remainder of the year.

First place winners should be 10 inches @ 200 dpi. 2nd, 3rd, HM: winners should be 7 inches widest measure @ 72 dpi. Files should be slugged accordingly: month_category_place.jpg Example: May_genews_1st.jpg.


